Day 3 | National Civil Rights Museum / Beale Street

Through interactive exhibits, historic collections, dynamic speakers, and special events, the National Civil Rights Museum offers visitors a chance to walk through history and learn more about this tumultuous and inspiring period of change in American history. Located at the former Lorraine Motel, the National Civil



Rights Museum honors and preserves the legacy of Dr. Martin Luther King, Jr. We continue to The Arcade, the oldest restaurant in Memphis, established in 1919. Sitting in the heart of historic downtown Memphis, The Arcade is like a step back in time. Scenes from *Great Balls of Fire*, *The Client*, *The Firm*, *Walk the Line*, and more have been filmed in this nostalgic diner.
